

# Dancer's Corner 2011-2012

## REGISTRATION/RECITAL FEE

\$85.00 for first child -- \$40.00 for each additional child

Registration Fee is assessed annually and is used to cover the costs of enrollment, insurance, music and music licensing, newsletters, mailing, and other administrative expenses. This fee is non-refundable.

Registrations are considered complete when Registration Form, Fees and Liability Waiver have been submitted.

The *Recital Fee* covers the expense of the recital (auditorium rental, auditorium insurance, custodial fee, lights, sound, decorations, program, advertising, security etc.)

**\*\*One DVD per family** will be provided at no extra expense for participating students. This fee is non-refundable.

## TUITION

Tuition for the dance studio is based on the season (August – April). Payments are broken down monthly for convenience and are due the first lesson of every month.

There are **NO REFUNDS** for missed classes.

Family rates are available for immediate family members only (siblings) in the same household.

A \$15.00 late fee will be assessed on the 15<sup>th</sup> of every month on tuition, dance supplies, shoes, costumes, etc. If your account is past due, all payments will be applied to past due amounts first.

## DISCOUNTS

Family Rates: FIRST CLASS-40.00---50% off the second class. Additional classes are \$10.00 each. This discount also applies to siblings registered for classes in the same season.

One Time Payments: 10% discount applied when full tuition payments are made (August-April)

Refer a Friend: Sign up a friend and receive a \$20.00 credit towards the next month's tuition----- (You and the friend will need to let me know)

Early Registration: All Registrations received in full before July 1<sup>st</sup> will receive a coupon worth 15% off new dance wear, shoes and dance bags purchased on shoe fitting days.

## COSTUMES

Costume Fee is \$70.00 per costume per class

Included in this fee: costume, tights or socks, and accessories needed for performance

\*The first costume will be **automatically billed** in September.

\*The second costume will be **automatically billed** in October.

\*All remaining costumes must be **PAID BY** November 10, 2011.

**\*\*\*Late fees also apply to costumes\*\*\***

There are **NO REFUNDS** on costumes

## CLASS PLACEMENT

Children are placed in classes where they will feel confident, in order to promote the highest level of self-esteem. When available, careful evaluation of past performance, ability, and attendance as well as age will go into all decisions of class placement. It is our desire to have each student placed in the best possible class for their *individual* learning needs.

\*\* Classes with six or less students are subject to cancellation with those students being placed into other available classes.

## DANCE CLASS ATTIRE

Absolutely **NO** jeans, denim, street and non-dance attire or shoes/sneakers/boots are permitted to be worn during class. Every class, including hip-hop, is assigned proper dance shoes which must be purchased and worn during all studio classes, rehearsals, and performances. Any student, including Faculty Assistants, not wearing the proper attire or shoes will be asked to sit out and watch their class. **PLEASE! PLEASE! PLEASE!** pack hairbands/bobby pins to pull hair up out of the face and up off neck. Hair in face is not only a distraction, but also dangerous to your child as well as others.

## HOLIDAYS

The studio observes Thanksgiving and Christmas holidays. Please check the calendar or our website for exact dates.

We are NOT closed for spring-breaks, teacher work days, Easter, Presidents Day, Martin Luther King Jr. Day, Halloween, Memorial Day, Labor Day etc.....

## STUDIO POLICIES

- Class observers, including family members, tend to be distracting. Especially to our youngest students. Only students, instructors and faculty members are permitted in the dance studio room during class. **"WATCH ME DANCE" week is November 7-10, 2011.** These are the **ONLY** dates set aside for watching..
- NO food, candy, gum or drink allowed in the dance studio room. Only clear, re-sealable water bottles.
- Please have your child use the bathroom before class.
- No cell phones allowed in dance studio room.
- The playground area behind the studio is not ours and **MUST** be avoided at all times!
- If siblings or friends wait, they must be under direct adult supervision at all times.
- Friends may wait in the lobby area only.
- We ask that students not leave their belongings around on the furniture or in the middle of the floor. There is a cubby area for them to store their belongings.
- Students are asked to bring their dance bags into class with them if taking consecutive classes.

## DROP-OFF/PICK-UP

When entering the parking lot, please enter from the bank side entrance so that children can exit the vehicle on the building side close to the door. Please exit using the driveway facing Skate City. Please be patient, courteous, and safety-conscious when dropping off and picking up students. The congestion in the parking lot can be considerable during class transitions. For safety purposes, we ask that you follow this traffic pattern. You never know when a child may run out the front door without looking first. Please do not park in the path of the drop off/ pick up shelter.
